

PARTICIPATION FEE

The registration fee covers the publication (dispatch) of the printed book of abstracts, but it is possible to participate only with the receipt of the electronic version of Abstract in pdf-format (the cost of such participation is given in brackets).

Full-time participation:

✓ Foreign participants - 100 EUR

✓ Foreign young scientists (under the age of 35), postgraduate students - 50 EUR

Correspondence participation:

✓ Foreign participants, postgraduate students (only electronic version) – 25 EUR.

The registration fee will include the payment for participation in the conference, a full set of conference materials (except for the correspondence participation) - conference program, book of abstracts, certificate of participation, accompanying materials, coffee breaks and general organizational expenses. Affiliates with the correspondence form of participation will receive a book of abstracts by mail (for this, in the cover letter, please indicate the sending address).

PAYMENT

Registration fee for foreign participants should be paid by cash at the time of registration.

Details of payment for correspondence participation will inform after receiving a registration form and abstract.

Conference materials will be published in book abstracts before the conference.

Requirements for abstracts.

Abstracts must have in volume <u>**2 full pages**</u> of <u>A5 paper format</u> and fields (except the left) - 22 mm, left - 20 mm.

The text should be prepared in Word file format, 11 pt. Times New Roman font, single-spaced text and 1.0 cm paragraph. The material should be done as a single file. The pages are not numbered.

The material should be placed on the following requirements:

<u>Authors:</u> printed with alignment on the left, without paragraph, initials and co-authors' names (bold, 11 pt), in brackets - city and country; (normal, 11 pt).

Skip 1 line.

Abstract title: next line centered in capital letters (bold, 11 pt) (without spaces).

Information about the organization where the work was done: the name of Institution or Organization, department should be placed in the middle (italic, 11 pt), preferred email address.

Skip 1 line.

Text (normal 11 pt), 1.0 cm paragraph, single-spaced text, alignment - in width.
