THE MODEL OF COMMUNITY HEALTH CLINIC OF LVIV POLYTECHNIC




The PROGRAM of the International Scientific and Practical Conference "Partnerships for Social Change: 20 Years of Experience" is based on the Model of Community Health Clinic of Lviv Polytechnic, as developed in the context of **"No Limits" Partnerships Networking**.
